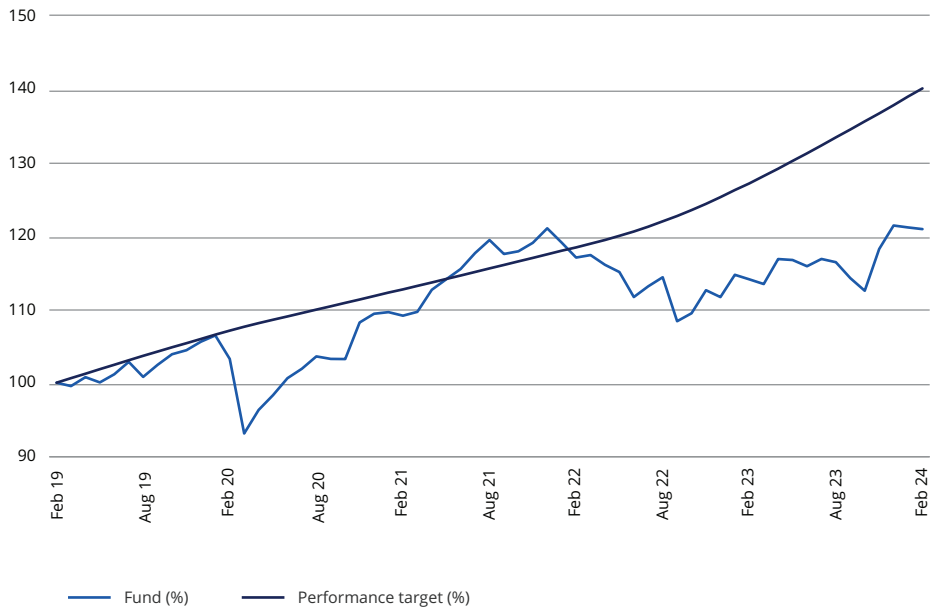
Important Information
