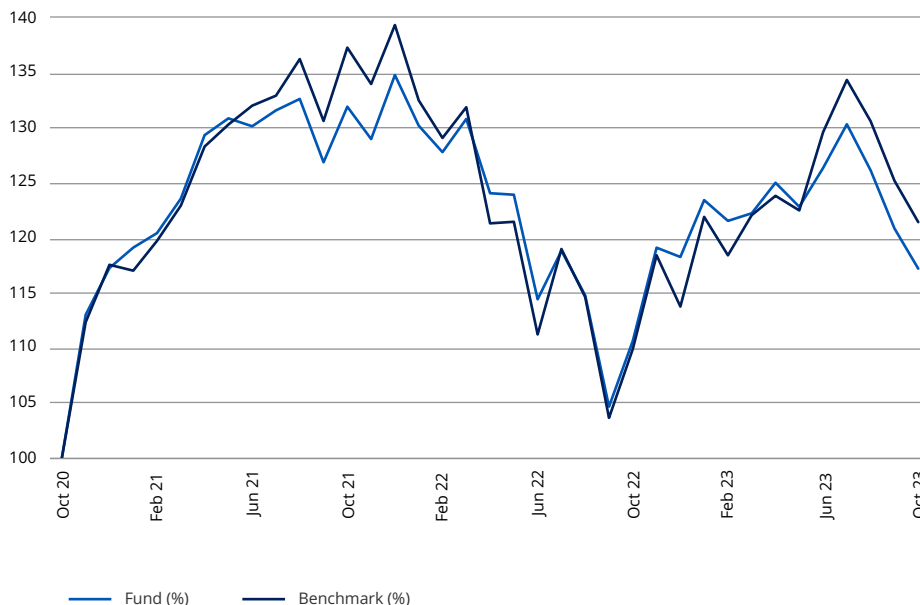
- The Fund invests in global equities and equity-related securities of companies which pay or are expected to pay dividends.
