Objective

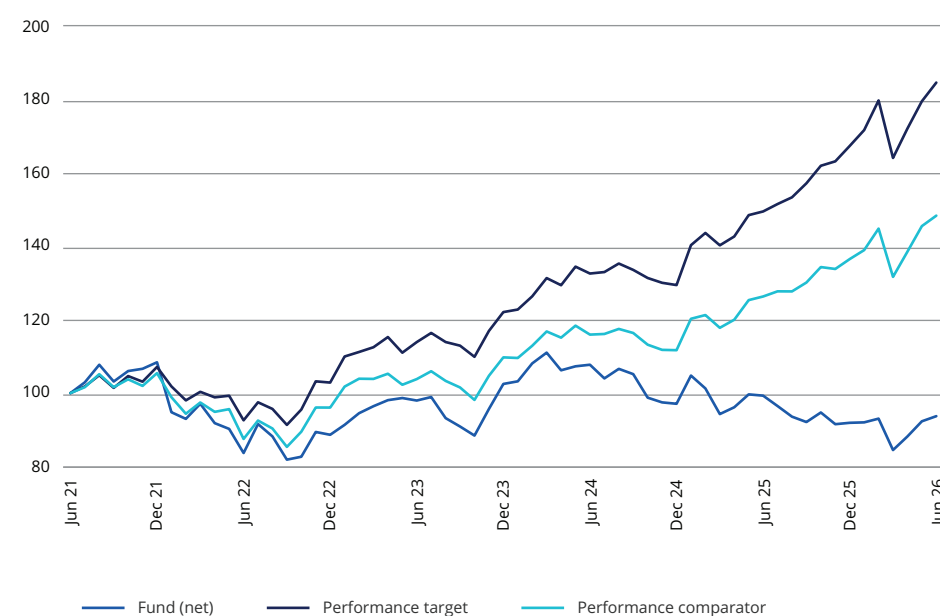
