Objective

To generate growth and income over the long term (5 years or more) by investing in European property-related equities (company shares) including listed closed ended Real estate investment trusts ("REITs").

Performance Target: To achieve a return in excess of the FTSE EPRA Nareit Developed Europe Index over rolling five year periods (after charges). There is no certainty or promise that the Performance Target will be achieved.

The FTSE EPRA Nareit Developed Europe Index (the "Index") is a representative index of European property related stock markets.

Portfolio securities

- The fund invests in European (including UK) property related equities.
- The fund may also invest in other funds (including those managed by Aberdeen Investments), cash and assets that can be turned into cash quickly.

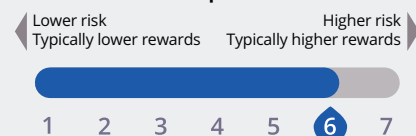

- The management team use their discretion (active management) to maintain a concentrated asset mix at sector and company level.
- Their primary focus is on selecting using research techniques to select individual holdings. The research process is focused on finding high quality companies that can be held for the long term through the assessment of their business model, the industry they operate in, their financial strength, and the capability of their management team.
- Due to the active nature of the management process, the fund's performance profile may deviate significantly from that of the Index.

Derivative usage
